DUTY OF INVESTIGATOR PER THIS AGREEMENT

1. AGENCY shall provide CLIENT with services that may include written reports, recorded statements, photographs, video, audio and related materials, as set forth by the terms and conditions below.
2. Pursuant to Florida Statutes Chapter 493.6119 (1) AGENCY will keep and maintain all reports strictly confidential. Except where required by law, no information from reports will be revealed to the person reported on or to any other person unless CLIENT gives express permission.

3. Reports can be delivered via US mail, faxed, hand delivered or via telephone upon consent from the CLIENT.
4. CLIENT agrees to pay AGENCY for all rendered services regardless of the outcome of said services. INTERNATIONAL PROFESSIONAL INVESTIGATORS, LLC does not guarantee surveillance to its CLIENT. Unless otherwise agreed CLIENT agrees to pay AGENCY for all work undertaken or to be undertaken at a rate of **\$75.00 (SEVENTY FIVE DOLLARS)** per hour billed in quarter hour increments for surveillance with a minimum of 8 hours. If in the event CLIENT request a second investigator , this will be billed at **\$55.00 (FIFTY-FIVE DOLLARS)** per hour with a minimum of 4 hours. CLIENT will be billed time beginning upon departure from the AGENCY office and terminating upon return to the AGENCY office. If CLIENT would like services to be undertaken on weekends after midnight or holidays the CLIENT shall pay AGENCY **\$85.00 (EIGHTY FIVE DOLLARS)** an hour also billed in quarter increments. The CLIENT shall reimburse AGENCY for all expenses reasonably incurred in connection with investigator's services hereunder, including mileage at the rate of **\$0.65 (SIXTY_FIVE CENTS)** per mile, tolls and any long distance call charges. CLIENT also agrees to pay a 7% Tax that is mandatory by Miami Dade and 8.2 % administrative fees that is charged on the total balance. It is further agreed that any and all court appearances pertaining to this case are billed at **\$125.00 (ONE HUNDRED TWENTY FIVE DOLLARS)** per hour plus associated expenses will be billed.
5. If CLIENT request from AGENCY other services such as reports of any kind CLIENT agrees to pay AGENCY \$_____ for each report given to CLIENT.
6. CLIENT shall pay AGENCY a retainer fee \$_____ against cost. It is further agreed that all fees paid to agency by retainer are considered earned upon receipt and nonrefundable. Payments in full are due to AGENCY by way of agreed retainer outlined in paragraph before. AGENCY shall not commence any work on behalf of CLIENT unless retainer is received or otherwise agreed between parties of this agreement. It is further agreed that all fees paid to AGENCY by retainer are considered earned.
7. In the process of obtaining requested information, AGENCY will comply with all provisions of Federal, State, and Local laws and regulations pertains to criminal conviction histories and/or bank account or confidential financial information and adhere to all current privacy rules and regulations. AGENCY assumes that all information sold to CLIENT will be used for lawful purposes only and CLIENT acknowledges that it has represented such to AGENCY.
8. AGENCY will endeavor to provide complete and accurate reports pursuant to this agreement. Nevertheless, CLIENT acknowledges that the information contained in such reports is obtained from sources including, but not limited to: public records, nonproprietary services and through observation or perception, which

- may require the exercise of judgment of interpretation. CLIENT further releases AGENCY, ITS OFFICERS, EMPLOYEES, AND AFFILIATED COMPANIES AND ANY COMPANIES OR INDIVIDUALS from which AGENCY obtains information included in a report, from liability arising or alleged to arise directly or indirectly from any negligent acts, errors, or omissions by any of the providers of information or AGENCY in connection with the preparation of any reports, written or verbal.
9. Name similarities may be included in the report due to lack of sufficient information to verify that the individual or entity is the subject or claimant of research. It is agreed that CLIENT will furnish AGENCY with true and accurate information to the best of the CLIENTS knowledge and ability at the time of this agreement. AGENCY reserves the right to decline, or withdraw from any assignment that might give rise to a conflict without explanation. CLIENT understands that knowingly supplying false, misleading or incomplete statements or information to AGENCY relating to said assignment will result in immediate termination of said assignment and forfeiture of all retainers and money paid to AGENCY. AGENCY does not draw conclusions, make representation, nor expresses any opinions regarding the information contained in the report.
 10. By requesting and receiving reports , the CLIENT agrees to indemnify and hold harmless AGENC, its officers and employees from any and all claims, liabilities, expenses, fees including attorney fees, cost, and judgments arising from CLIENTS use or possession of the information furnished in said reports.

CLIENT agrees that AGENCY is engaged **solely by yourself or your company**, regardless of your clients ability and /or willingness to pay and further agrees that if any invoice is not paid by **you or your company** within seven days after it is rendered, it will be subject to a service charge at the rate of 7% per week and you will be responsible for any reasonable expenses associated with **collections** including, but not limited to :our time at our standard hourly rate and all attorney fees related to collection of any past due amounts from CLIENT.
